Under Colorado law, landlords must act fast when serious issues arise:

- 72 hours to inform tenants if the issue affects health/safety
- 7 days to make major repairs
- If you don't respond in time, tenants can escalate and penalties may follow.
- 5 Tip: Keep your reserve fund healthy so you can act quickly.

Service the HVAC System

Legal Reminders & Program Changes

TANF, T-SNAP, and Section 8 Housing Updates:

- If your tenants are protected under the CARES Act, 30 days' notice is required for all demands.
- Stay compliant, especially if your renters receive housing assistance.
