♠ New Colorado Law: Mandatory Section 8 Acceptance (HB25-1240)

Effective January 1, 2026, Colorado landlords will be required to accept Section 8 Housing Choice Vouchers.

This major update prohibits landlords from rejecting applicants solely based on their source of income, including:

- Housing vouchers (Section 8, VASH)
- · Rental assistance from nonprofits
- Disability or veteran payments

What You Need to Know:

- We can still screen applicants, but not deny them just because they have assistance or based on their credit score.
- We must state voucher acceptance in your listings and marketing.
- Violations can lead to legal penalties and fines.
